Terms of publication

and rules for the design of articles

Articles submitted to the editorial office of the journal are subject to mandatory review. By the decision of the editorial board of the journal, they can be sent for revision or rejected for formal or scientific reasons. In these cases, the editorial board does not enter into a polemic with the authors.

Only previously unpublished author's manuscripts of articles are accepted for publication in the journal. The affected topic should be distinguished by scientific and practical significance, originality of content.

The volume of the article (the text of the article, graphic material, literature) should not exceed 10 A4 pages with 1.5 line spacing. The font size is 14 Times New Roman. It is necessary to submit an electronic version of the text in the format of a Word text editor (any version).

It is advisable to adhere to the following order of design and the corresponding structure of the article:

- 1) UKD specify the heading of the article, as well as the Universal Decimal Classification Index (on the Internet the UDC Classifier);
- 2) The title of the article is the title, you can not use an abbreviation and formulas.
- 3) full name of the author after the initials and surname of the author follow: academic degree, academic title, position, place of work (study), city, country, e-mail;
 - 4) Abstract:
- abstract 850 characters, at least 10 lines includes the relevance of the research topic, problem statement, research objectives, methods and results of the study);
- keywords 8-10 words and phrases reflecting the specifics of the research topic introduction;
- -main provisions a brief reflection of the key results of the study, discussion of the results obtained and their comparison with previously known;

- 5) design in English, clearly according to the points: UKD, title of the article, full name of the author, abstract (abstract, keywords, main provisions)
 - 6) The text of the article:
- introduction formulation of the purpose and objectives of the study, a summary of the status of the issue under consideration and the formulation of the problem to be solved in the article;

-materials and methods of solving the problem: a detailed description of the study;

-results – the main content of the article (proofs of the provisions presented in the article, initial and final mathematical expressions, mathematical calculations and transformations, experiments and calculations, examples and illustrations are presented);

-discussion- contains an interpretation of the results of the study, including: compliance of the obtained results with the research hypothesis; limitations of the study and generalization of its results; suggestions for practical application; suggestions for the direction of future research.

- conclusion conclusions and recommendations.
- 7) List of sources sources used in the preparation of the article.

The bibliographic list (literature) is provided in accordance with the requirements of GOST 7.0.5-2008. The reference to the source used is made in square brackets, for example [1-3], [7, 8]. References to formulas, figures and tables are made using parentheses, for example formula (3), equation (1), (Fig. 2), (Table 7).

The number of drawings and photographs for the article should not exceed 5. Formulas (OST 29.115–88) are given in the format of a text editor. To symbolize physical (technical) quantities, use only the Latin and Greek alphabets, while in the text for Greek letters you need to use a straight font, for Latin letters – an oblique font (italics), vectors are indicated in bold or with an arrow above the vector symbol. For lower and upper indexes, use Arabic numerals, Latin or Greek letters. The dimension of physical quantities is indicated only by Russian letters.

Formulas, tables and figures should have a separate end-to-end numbering. If there are no additional (returnable) references to a specific formula in the text or it is in the singular, then numbering is not necessary. The only table and figure are also not numbered.

The article must be signed by all authors. Information about the author (or all authors) is presented on a separate sheet: surname, first name, patronymic, academic degree, title; position, education, experience of scientific (professional) activity, sphere of scientific interests (research directions), number of scientific papers, telephone, postal address (for the direction of the journal), e-mail.

Manuscripts are not returned.

The authors (or the author) of each article after its publication have the right to receive one copy of the journal.
